1. GPS data were obtained from the SHTA (<http://www.shta.org/Trail/TrailGPS.php>), downloaded 11/22/13. The KML file of 30,000 points and corresponding tracks in Google Maps and Google Earth were used to identify the main SHT path. Spur trails were excluded.
  2. Elevations along these tracks were obtained using Google Earth. The elevation profile function provided summary statistics, including elevation gain and loss, of trail segments.
  3. Elevations were spot checked using USGS and ESRI topographic maps (<http://www.mappingsupport.com/p/gmap4.php>).
  4. Distances computed by Google Earth and Google Maps generally aligned with those listed in the *Guide to the Superior Hiking Trail*. Where there were discrepancies that could not be explained, distances listed in the *Guide* were used in this table.
